OFFICIAL RULES**

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.** Free entry is available through the website at www.cloakroomdc.com.

2. **HOW TO ENTER:** Beginning on May 4, 2020 at 9:00am Eastern Daylight Time (EDT) through May 23, 2020 at 12:01am EDT, log on to www.cloakroomdc.com and click on the icon for the Employee and Entertainer Support Raffle and follow the on-screen entry instructions. There are two ways to enter: make a donation to the Employee and Entertainer Support Fund with each entry or request a free entry. Entrants must fill in all required information and you will receive email confirmation with each entry. Limit one (1) free entry per email address.

3. **USE OF FUNDS:** All money collected by this raffle will go to the Employee and Entertainer Support Fund, and will be used to support Sponsor's employees and entertainers who have not been able to work or are experiencing financial hardships due to the COVID-19 outbreak.
